#### FINANCIAL ASSISTANCE

Tuition assistance is available for Lower & Upper school families demonstrating a financial need.

Traders Point Christian Schools (TPCS) participates in the Indiana Choice Scholarships Program and the Scholarships for Education Choice Program (Sagamore SGO), and offers a limited amount of direct assistance.

#### APPLICATION FEE

A one-time, \$27 non-refundable application fee is charged for each new applicant to TPCS. This fee is paid during the online application process and does not apply toward tuition.

#### DEPOSIT

A one-time, \$500 refundable deposit is collected for each student enrolled at TPCS. This deposit is paid during the online enrollment process and is refundable upon graduation or with proper notice of withdrawal. An Intent Not-to-Return Form is due by March 15 of the applicable year to have your deposit returned (see additional details in the enrollment packet regarding withdrawal).

#### LATE FEES

A 1% monthly service fee may be charged on all past due account balances.

#### PAYMENT OPTIONS

Payment plans for tuition begin in June for the following school year, with all payments due by May 31 of the applicable school year. Various payment options are available, including annual, monthly, and semi-monthly. You will select your plan type during the enrollment process and that plan will remain in place for each successive year, although you can change your plan selection upon request.

#### FULL-PAY DISCOUNT

A 4% tuition discount is offered for any account paid in full by August 1 of the applicable school year.

#### SEMI-ANNUAL PAY DISCOUNT

A 2% tuition discount is offered for any account paid in half by August 1 and the remaining balance by December 15 of the applicable school year.

#### INCIDENTAL EXPENSES

Incidental Expenses will be posted to your FACTS Account monthly and will be due within 30 days or by the specified due date, whichever is later.

#### **NON-PAYMENT OF TUITION & FEES**

During the school year, any student with a past due balance may not be allowed to attend classes or participate in extracurricular activities until the account is brought current. Any student with an outstanding balance from a prior year will not be allowed to start classes the following year. In addition, records will not be released for any student with an outstanding balance. Repeated incidents of non-payment may result in dismissal from TPCS. Each person with financial responsibility for a student will be responsible for any collection fees incurred.
